4. Coordinated Entry Monthly Data Presentation and BfZ Report Update // Stephanie Smith, CE Administrator, CCHA and Meghan Morrow-Raftery, ICA

5. Veteran Prioritization // Stephanie Smith, CE Administrator, CCHA and Jason Brill, VA

- o Jason presented the need to update the Veteran Prioritization Policy post expiration due to an unforeseen increase in enrollment during the first few months of the policy.
- The Coordinated Entry committee also requests to determine a measure of success for the policy
- MOTION made by Sarah Russell, seconded by Will Towne, to vote to approve the CE
 Committee request for approval from the CCHA Steering Committee of the Veteran
 Prioritization Policy to ensure the CCHA reaches its goal of Functional Zero for Veteran
 Population and extend through December 31st, 2023
 - i. The group discussed the decision to prioritize veterans over other homeless populations and the usefulness to the overall mission.

6. CCHA-City of Burlington, Planning Dept. MOU // Sarah Russell, CEDO City of Burlington

- Given the City of Burlington's goal to end chronic homelessness by 2025, the City requests the CCHA share relevant data for their housing dashboard
- MOTION made by Travis Poulin, seconded by Jason Brill, to vote to approve the City of Burlington request to partner around publishing current, accurate, aggregated data and execution of related documents/agreements

7. CCHA-Dept. of Health Social Autopsy MOU // Meghan Morrow-Raftery, ICA

- The Vermont Department of Health (VDH) are requesting to send the statewide data of overdose deaths so the CCHA (ICA) could return an aggregated number of folks who were from Chittenden County and in HMIS
- Sarah Russell recognized the importance of the data but wanted to acknowledge that it could further contribute to the stigma of folks experiencing both homelessness and substance use disorder

- MOTION made by Travis Poulin, seconded by Will Towne, to vote to approve the VT HMIS Advisory committee request for approval from the CCHA Steering Committee to allow ICA to send aggregate HMIS data to the VT DOH for their Social Autopsy project to understand linkages between homelessness and substance use

- o Will Towne, Spectrum Youth and Family Services
 - O Spectrum receives approximately \$358,000/year in HOP funding to support its RRH program, year round Emergency Shelter, and Winter Warming Shelter. Over the first 2 quarters, the ES and RRH programs have served 25 unique individuals with the ES program operating at 96% occupancy rate. In the last 1.5 months of the Warming Shelter, we have housed 16 youth. Unfortunately, due to staffing challenges, this program opened significantly later than expected. We also continue to see in an increased need regarding mental health and substance use supports.
