- 1. Introductions and Announcements
  - a. CCHA Community Meeting
    - i. Sarah Russell, CEDO Thursday June 8<sup>th</sup> at 4:30pm, there will be a CCHA Community Meeting. This is in place of the Steering Committee Meeting for the month.   - b. Hotel Updates
    - i. Stephanie Smith, CVOEO Kerri Duquette-Hoffman let me know that AHS is trying to help households currently in the hotels who are 70-years-old and over to help them plan for when they must leave their hotels June 1<sup>st</sup> or July 1<sup>st</sup> (most are approved to stay through July 1<sup>st</sup>).

#### c. CE Updates

- Stephanie Smith We have lots of referrals in process. We are working on distributing the next 15 HOME vouchers. Of those already distributed, one household has been housed, and two or three more are in process to move into housing.
- 2. Discussion on having Co-Chair of the CE Committee Sarah Russell
  - a. Sarah Russell Other CCHA committees have co-chairs because the workload is just too much for one person. This could help to spread the work load and have balanced facilitation at meetings. Stephanie has a lot on her plate, if work needs to happen between meetings, having a co-chair would help her be able to get that work done. I am proposing that we have co-chairs for this committee.
  - Will Towne, Spectrum I agree. CE keeps growing and running this committee is a lot of work.
  - c. Stephanie Smith I am open to this, I run six community meetings a month and would welcome some help with this meeting.
  - d. Jason Brill, VA/VVCH Would this co-chair just be helping with this meeting or would they help with one of the other six meetings you mentioned that you are running?
    - i. Stephanie Smith Yes, they would be helping just with this meeting. I enjoy running other meetings. I do not think co-chair could help with the work outside of meetings because I need to do the follow up work so working together with someone on that would be a lot of back and forth and not a lot of help.
    - ii. Sarah Russell In terms of workload, there is some prep time around agenda setting, people are in touch, cochairs would have to prioritize, if there were

need for other presenters, ensuring that that presenter can be there to facilitate that portion.

- e. Sarah Russell Is there anyone with interest in taking on the role of co-chair of this committee with Stephanie?
  - i. Crystal Jones I have not been super involved in this group. We do a lot here and I would love to help support our work. This would also be an opportunity for professional and personal growth as I have not facilitated a lot of large meetings.
  - ii. Will Vilardo I live in CE every day, you can see how it informs policy, helps case managers, focusing on meeting goals. Have a clear and good CE system is how we achieve all of that and I want to support this work.
  - iii. Sophia Senning CE is expanding and growing and the work that this committee does is growing and expanding, I have a solid insight in terms of supervising front line staff and the shelter. I think I appreciate this group and all that it does and they are ways we can improve and I would love to be a part of that conversation.
