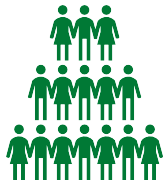

Adverse Weather Condition (AWC)

This is the current eligibility data on all households in the GA Housing program as of 12/4/2023.

- Eligibility is currently identified night to night, depending on weather conditions.
- From December 15th through March 15th the program moves to eligibility independent of weather forecasts and can be approved at 30-day increments.

We encourage clients and housing partners to review the Adverse Weather Condition's website to see if the weather conditions in the area meet the eligibility criteria.
- To date we have housed 421 unique households on cold weather nights (11/15/2023-12/4/2023)
